

**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**WHEREAS,** the Tribal Council on November 13, 1991, enacted Resolution No. 11-91-329; and

**WHEREAS,** the last "Be it resolved" clause in the resolution states "that the skidding of tree-top stems shall be limited to those which pose a risk of damage to residual trees when burned on areas greater than 30 acres in size in which 3,000 board feet per acre or more are cut"; and

**WHEREAS,** said language should be modified to be in conformity with the understanding between the Tribal Forestry and BIA Forestry and should read as follows:

"That the skidding of tree top stems shall be limited to those which, if burned, would pose a risk of damage to residual trees".

and

**WHEREAS,** the Tribal Council agrees that the language should be so modified.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby amends Resolution No. 11-91-329 so that the last Be it Further Resolved reads:

"BE IT FURTHER RESOLVED by the Tribal Council that the skidding of tree top stems shall be limited to those which, if burned, would pose a risk of damage to residual trees."

**BE IT FURTHER RESOLVED** by the Tribal Council that any and all other provisions of Resolution No. 11-91-329 shall remain in full force and effect.

The foregoing resolution was on December 12, 1991, duly adopted by a vote of NINE for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
