Regulations requiring a current Board of Directors with appropriate authority from the Tribal Council to conduct radio station business and operations; and
- the Tribal Council, by previous resolution, approved a WHEREAS, reduction in the size of the board from nine to six members, one of which was an ex-officio non-voting member; and
- the Tribal Council hereby affirms the reduction in size WHEREAS, of the Board to six members, one of which will be exofficio and non-voting; and
- the following persons are recommended to the Tribal WHEREAS, Council to be appointed to the Board:

- WHEREAS, the Tribal Council concurs with the above recommendation.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache -Tribe that it hereby appoints the following persons for the following terms of years to the Board of Directors for the Apache Radio Broadcasting Corporation:
 - 1. Charles O'Hara _ years 2.
 - Irvin Santiago <u>3 years</u>
 - 3. Marilyn Endfield _ years 4.
 - Raymond Kane _ years
 - Erwin Thompson 5. _ years
 - 6. Father Ed Fronski years as Ex-officio and non-voting member

- BE IT FURTHER RESOLVED by the Tribal Council that the newly appointed Board of Directors shall exercise any and all powers granted to said Board pursuant to the Articles of Incorporation and Bylaws of the Apache Radio Broadcasting Corporation.
- BE IT FURTHER RESOLVED by the Tribal Council that it hereby directs the Tribal Attorney to draft appropriate amendments to the Articles of Incorporation and Bylaws to reflect the prior resolutions reducing the size of the Board from nine members to six members, one of which is ex-officio and non-voting.
- BE IT FURTHER RESOLVED by the Tribal Council that it hereby expresses appreciation to the former Board of Directors and thanks each member for services rendered to the Apache Radio Broadcasting Corporation.

The foregoing resolution was on February 13, 1992, duly adopted by a vote of $\underline{\text{six}}$ for and $\underline{\text{zero}}$ against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) (s) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
