- WHEREAS, the necessary documents of relinquishment of headrights were read and signed by Aletha Jane Indian, in the presence of a Notary Public on March 04, 1992, and are attached hereto.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby grants the Tribal relinquishment request of Aletha Jane Indian, and her tribal membership with the White Mountain Apache Tribe is granted relinquished this date.

The foregoing resolution was on March 18, 1992, duly adopted by a vote of six for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article III, Section 3 of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

Further, I realize that I will no longer have fishing or hunting privileges on the Fort Apache Indian Reservation; no homesite or farmland assignments, or claim to have title to any resources of the WHITE MOUNTAIN APACHE TRIBE, or monies distributed pursuant to Judgment under the Indian Claims Commission Act.
