RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

- WHEREAS, the Tribal Council on October 2, 1991 adopted Resolution No. 10-91-244 in which it requested that the BIA Roads Department improve the road to Lucille Willie's residence; and
- WHEREAS, the road has not been improved due to Bureau regulations regarding the BIA road system; and
- WHEREAS, Ms. Willie's road is not on the BIA road system at this time and the Tribal Council concludes that it should be added to the BIA road system; and
- whereas, the area in question known as the Power Line Road has at least 25 land assignments surrounding it and at least three (3) houses in the area which would be served by the proposed BIA road between Highway 73 and Power Line Road; and
- WHEREAS, the Tribal Council concludes that the road between Highway 73 and the Power Line Road should be improved with the application of gravel to stabilize and make the road passable to the homes in the area including Mrs. Willie's; and
- WHEREAS, the Tribal Council on October 2, 1991 also adopted Resolution No. 10-91-256 which requested the Bureau of Indian Affairs to assist families in that resolution by improving roads to their homes which are impassable in inclement weather; and
- WHEREAS, the Tribal Council concludes that the roads identified in Resolution No. 10-91-256 should also be added to the BIA road system; and
- whereas, in respect to Marie Gregg, the Bureau of Indian Affairs has requested an 80 foot right of way to her home and the Tribal Council concludes that the request should be granted and further that to the extent the roads described herein, in Resolution No. 10-91-256 and Resolution No. 10-91-244 are incorporated into the BIA road system, that right of ways should be granted thereto to the Bureau of Indian Affairs; and
- whereas, the Tribal Council concludes that a reasonable time line for the Fort Apache Agency to obtain area office approval and for improvement of the roads is 90 days.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby request that the Fort Apache Agency, Bureau of Indian Affairs add as part of the BIA road system the roads to the following homes:

1. Cibecue

- (a) Curtis and Zella Albert
- (b) Otis and Doris Danford
- (c) John Mason
- (d) Wilson Gregg, Sr.
- (e) Marie Gregg
- (f) Lincoln and Nora Johnson
- (g) Sam Nachu

2. Alchesay Flats Area

- (h) Lucille Willie's residence between Highway 73 and Power Line Road graveling.
- BE IT FURTHER RESOLVED by the Tribal Council that to the extent that the BIA incorporates the foregoing roads into the BIA road system, the White Mountain Apache Tribe hereby grants a right of way to the BIA for said purposes.
- BE IT FURTHER RESOLVED by the Tribal Council that it hereby authorizes the Bureau of Indian Affairs to utilize crushed stone previously prepared by Fort Apache Materials for a BIA road project but rejected to be utilized for road improvement to the Cibecue homes listed herein contingent upon said crushed stones not having been previously committed to other tribal enterprises or other purposes and subject to the approval of Tribal Chairman Ronnie Lupe.

The foregoing resolution was on <u>June 4, 1992</u>, duly adopted by a vote of <u>ten</u> for and <u>zero</u> against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (e) (h) (i) (u) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
