RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

- WHEREAS, it has been the custom in the past for the current White Mountain Apache Tribal Council to recognize and honor past leaders for their dedication and service to the Tribe; and
- WHEREAS, the Arizona Commission on Indian Affairs will be honoring two past leaders at the 1992 Tribal Fair and Rodeo, for their distinguished service to the White Mountain Apache Tribe; and
- WHEREAS, it is important for the Tribe to recognize and to honor past leaders for their commitment and efforts on behalf of the White Mountain Apache Tribe, and to acknowledge their work; and
- WHEREAS, there are currently four (4) past leaders who are over 65 years of age; Nelson Lupe, Sr., Lester Oliver, Fred Banashley, Sr., and Fred Larzelere, Sr.; and
- whereas, the Tribal Council wishes to recognize and honor these men for their service to the Tribe, for their protection of the Apache way of life; its customs and traditions; for because of their struggles, the White Mountain Apache Tribe continues to thrive, and to hold its ancestral lands; and
- WHEREAS, the Tribal Council of the White Mountain Apache Tribe wishes to recognize and compensate past Tribal leaders who have retired and have attained the age of 65; and
- whereas, the White Mountain Apache Tribal Council, in recognition of the service of these men named above, hereby decrees that each should be compensated in a manner consistent with tradition and in commemoration of their past outstanding service to the Tribe.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache that it hereby recognizes the exemplary service and dedication of past Chairmen Nelson Lupe, Sr., Lester Oliver, Fred Banashley, Sr. and Fred Larzelere, Sr. to the White Mountain Apache Tribe.
- BE IT FURTHER RESOLVED by the Tribal Council that each of these past chairmen shall receive compensation in the amount of \$200.00 per month retroactive from May 1, 1992 henceforth on, for their past service and commitment to the White Mountain Apache Tribe.

BE IT FURTHER RESOLVED by the Tribal Council that the Tribal Treasurer is directed to carry out the dictates of this resolution.

The foregoing resolution was on <u>September 01, 1992</u>, duly adopted by a vote of <u>nine</u> for and <u>zero</u> against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
