## RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

- WHEREAS, the Tribal Council is advised that Pascal Ethelbah, Jr., Mario Jovenal and Lloyd Leo Massey, enrolled members of the White Mountain Apache Tribe, have each reached the age of 18 and are now eligible for their per capita distribution of the proceeds of the settlement of claims in the Western Apache Claim, Docket 22-D; and
- WHEREAS, the Tribal Council is further advised that messrs. Ethelbah, Jovenal and Massey have not received their per capita distributions because inadvertently their names do not appear on the Tribal membership rolls that were established for the purpose of distributing the Docket 22-D settlement funds to Tribal members; and
- WHEREAS, the Tribal Council concludes that Messrs. Ethelbah, Jovenal and Massey should receive their share, without further delay, from other Tribal funds regardless of the omission of their names from the Tribal rolls that were established to distribute the Docket 22-D settlement funds; and
- WHEREAS, the Tribal Council is advised that Messrs. Ethelbah, Jovenal and Massey's shares could be paid from the Chairman's Public Relations fund and that reimbursement to that fund could be made from the Bureau of Indian Affairs.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs the Tribal Business Office to disburse from the Chairman's Public Relations fund, the amount of \$1343.43 each to Pascal Ethelbah, Jr., Mario Jovenal and Lloyd Leo Massey, which represents their per capita shares of the proceeds from the Docket 22-D settlement funds.
- BE IT FURTHER RESOLVED by the Tribal Council that Tribal Chairman Ronnie Lupe, or his designee, is authorized to submit a request for reimbursement in the amount of \$4030.29 to the Bureau of Indian Affairs.

The foregoing resolution was on <u>November 12, 1992</u>, duly adopted by a vote of <u>ten</u> for and <u>zero</u> against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) (k) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
