RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

- WHEREAS, on July 14, 1993 the Tribal Council passed a resolution approving the location of the Cibecue Airport Compound comprised of approximately 130.427 acres; and
- WHEREAS, the Tribal Council has reviewed this earlier decision and found the same to be sound; and
- WHEREAS, the Tribal Council has discussed this matter with the Livestock Associations and the Land Board, and have found there to be no apparent or substantial disagreement with the location of the airport at the proposed site.
- BEIT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby reaffirms its decision to locate the airport at the site described in the attached legal description dated July 13, 1993, as address in the prior Tribal Council Resolution No. <u>07-93-202</u>.

The foregoing resolution was on <u>June 01, 1994</u>, duly adopted by a vote of <u>nine</u> for and <u>zero</u> against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (h), (i), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


