

**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

WHEREAS, by petition East Fork and Seven Mile community members have requested Tribal Council approval to utilize \$700.00 from the East Fork, Turkey Creek and Seven Mile Land Claims Account to purchase supplies so they may enter a float in the Tribal Fair; and

WHEREAS, Tribal Council concurs with said request.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes \$700.00 to purchase supplies for a float from the East Fork, Turkey Creek and Seven Mile Land Claims Fund.

The foregoing resolution was on August 30, 1994, duly adopted by a vote of 6 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (b) (i) (j) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
