WHEREAS, the United States of America, acting through the Indian Health Service, Department of Health and Human Services, hereinafter referred to as the IHS, under and pursuant to the provisions of Public Law 86-121 (73 Stat. 267), and the White Mountain Apache Tribe, hereinafter referred to as the Tribe, acting through the White Mountain Apache Tribal Council, entered into a Memorandum of Agreement executed for the IHS on May 31, 1989, and signed for the Tribe on June 21, 1989, regarding the provision of sanitation facilities on the Fort Apache Indian Reservation, and

WHEREAS, the project provided for under the Agreement has been completed, and

WHEREAS, the IHS has a vested interest in the community wastewater treatment facilities and the appurtenances, materials, supplies, and equipment provided for and incorporated therein pursuant to the aforesaid Agreement, and

WHEREAS, the parties desire to provide for and assure the proper and efficient maintenance and continued operation of the sanitation facilities, and

WHEREAS, under Section 7(a)(4) of Public Law 86-121, the IHS on behalf of the United States of America is authorized to transfer the completed facilities with or without a monetary consideration, and under such terms and conditions as in its judgment are appropriate, considering the contributions made and the maintenance responsibility undertaken, and the special needs of the Indian people.

NOW THEREFORE, in accordance with the terms of the aforesaid Agreement, and pursuant to Section 7(a)(4) of Public Law 86-121:

1. The IHS hereby transfers, assigns, and conveys to the Tribe, without a monetary consideration and under the terms and conditions set forth in the Agreement, all of the right, title, and interest of the United States of America in all community facilities and appurtenances thereto constructed. These facilities include, but are not limited to, the items listed on Attachment A.

- 2. The IHS will assist the Tribe in start-up operations of the system and will correct any defect related to material or workmanship jointly identified by the Tribe and the IHS for a period of one year after the date of the beginning of beneficial use of the facilities or the date of transfer of the facilities, whichever occurs first (date of beneficial use began on November 30, 1992). This warranty is limited only to the equipment and facilities provided by the IHS under this project. This warranty does not cover normal wear and tear of equipment, replacement parts, operational costs, or abuse or vandalism to equipment or facilities.
- 3. The Tribe hereby accepts such transfer of facilities listed on Attachment A under the terms and conditions set forth in the aforesaid Agreement and agrees to operate, maintain, and repair such community facilities as the property of the White Mountain Apache Tribe to keep the facilities in an effective operating condition.
