## RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

- WHEREAS, the White Mountain Apache Housing Authority of the White Mountain Apache Tribe is eligible to apply for funding from the DHUD for the Youth Sports Program; and
- WHEREAS, eligible activities of the Youth Sports Program include expenditures for facilities that contribute to the availability of sports facilities for youth residing in public housing; and
- WHEREAS, the vast majority of housing on the Fort Apache Indian Reservation is public housing and the availability of facilities to support youth programs is limited for most purposes to school facilities and to the gyms at Whiteriver and Cibecue; and
- WHEREAS, the greatest recreational facility need is for outside facilities; and
- WHEREAS, the Youth Sports Program requires matching funds of at least 50% of the project cost; and
- WHEREAS, the White Mountain Apache Tribe, State of Arizona and Navajo County have developed Phase I of the Tribal Park at a cost of \$65,000 exclusive of land costs; and
- WHEREAS, the completion of the Tribal Park will provide basketball and volleyball courts, horseshoe pits, playground equipment, as well as restrooms and lighting for the Park, all under the supervision of the Tribal Athletic Association, providing needed facilities for the youth of the Fort Apache Indian Reservation.
- BEIT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby encourages the White Mountain Apache Housing Authority to submit the Youth Sports Program application to complete the Tribal Park.
- BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it authorizes the Phase I costs of \$65,000, the appraised land value of \$51,200 and the additional sum of \$134,926 to fully complete the Park be committed for matching funds for this grant application and that the Athletic Association be authorized for operational funds in the amount of \$45,350 to operate and maintain the Park in the next tribal budget.

## Resolution No. <u>03-95-101</u>

The foregoing resolution was on March 08, 1995, duly adopted by a vote of nine for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (h), (i), (j), (k), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
