- WHEREAS, the Tribal Council is advised that \$875.14 is requested for equipment from Play It Again Sports and \$410.90 for uniforms from High Country Awards, for a total request of \$1,286.04 from the Diamond Creek Land Claims Fund; and
- WHEREAS, Randy Walker further advise the Tribal Council that the petition attached will be submitted to the Tribal Council Secretary as required by tribal policy; and
- WHEREAS, the Tribal Council concurs with the Diamond Creek Community's request.
- BEIT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes \$1,286.04 be withdrawn from the Diamond Creek Land Claims Fund for equipment and uniforms for the North Fork Rockies Little League Team.

The foregoing resolution was on May 03, 1995, duly adopted by a vote of nine for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (h), (i), (k), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
