RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION

- WHEREAS, the Tribal Council has been advised about the Arizona Indian Festival to be held on January 12, 13, and 14, 1996 on the Phoenix Indian School property; and
- WHEREAS, the Festival is being held as a sanctioned event, prior to Super Bowl XXX on January 28, 1996; and
- WHEREAS, the Indian Festival offers a unique opportunity for a historic gathering of all Arizona Indian Tribes in one location to showcase their rich culture; and
- WHEREAS, the White Mountain Apache Tribe has been given an opportunity to assist in the construction of an Apache Village, a Tribal Economics Exhibit and participate in an Arts and Crafts Fair as well as food booths; and
- WHEREAS, the Tribal Tourism department has taken a lead role in the presentation of the Super Bowl XXX Indian Festival and thereby reflecting Apache Culture; and
- WHEREAS, the Arizona Super Bowl Tribal sponsorship package has been presented to the White Mountain Apache Tribe.
- BEIT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby appropriates \$5,000 to the Arizona Super Bowl XXX Indian Festival Arizona American Indian Tourism Association (AAITA) for use in accordance with the Tribal Sponsorship package attached and incorporated by reference to this resolution.
- \$5,000 for the construction and maintenance of the Apache Village and related activities to be expedited and coordinated through the Office of Apache Tourism pursuant to the budget attached hereto and incorporated by reference herein.
- BEIT FURTHER RESOLVED by the Tribal Council that the Director of the Apache Tourism Office is authorized to expedite and coordinate the activities of the White Mountain Apache Tribe in conjunction with the Super Bowl XXX Indian Festival.

The foregoing resolution was on December 06, 1995, duly adopted by a vote of ten for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (i), (g), (k), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
