## RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

- WHEREAS, Tribal member Theresa Warrick and her husband, Vincent Warrick, have come before the Tribal Council to seek permission to operate a towing service on the Reservation; and
- WHEREAS, the Warricks would also like to provide minor automobile repairs at their residence in the North Fork area; and
- **WHEREAS**, the Warricks understand that Tribal Council permission is required prior to beginning a new business within the Reservation; and
- WHEREAS, the Tribal Council recognizes the need for auto repair services, and yet will not allow a business operation in a residential area which would disturb the other residents; and
- WHEREAS, the Tribal Council recognizes the benefit of permitting new entrepreneurs to undertake projects which will serve the community; and
- WHEREAS, the Tribal Council shall grant only a short term permit to give Warricks an opportunity to begin their business and then to come back to the Council with a report on its progress.
- **BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby permits Tribal member Theresa Warrick and her husband, Vincent Warrick, to provide towing services within the Reservation, subject to the following conditions:
  - 1. the duration of the permit shall extend for ten (10) weeks only;
  - 2. the tow truck shall at all times during the term of the Permit have in place a policy of comprehensive liability insurance for the towing operations;
  - 3. the towing vehicle shall at all times during the term of the permit be licensed by the State of Arizona pursuant to A.R.S. Title 28, in order to operate the tow truck on state roads and right-of-ways;
  - 4. the Warricks shall not be permitted to remove any vehicle from the Fort Apache Indian Reservation, except with the prior written consent of the owner.

- BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Warricks are also permitted to provide minor automobile repair services at the location of their residence at North Fork, provided that no more than four (4) vehicles are on the premises at one time for repairs, and that the operation does not disturb any of the neighbors in the vicinity.
- **BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that upon the termination of the short-term permit, the Warricks shall return to the Tribal Council to seek permission for an extension of the existing Permit and/or the award of a long-term towing permit, and that they shall bring a business plan to the Tribal Council to demonstrate the projected feasibility of business.
- **BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the permission granted under this Resolution is revocable at any time, for any reason, at the discretion of the Tribal Council.

The foregoing resolution was on <u>April 10, 1996</u>, duly adopted by a vote of <u>ten</u> for and <u>zero</u> against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (b), (h), (t), (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
