

**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**


- WHEREAS,** the Tribal Council has been advised that former Tribal Councilmember Darvin Burnette passed away on Sunday, June 09, 1996; and
- WHEREAS,** the Tribal Council extends its sincere sympathy to Mr. Burnette's family; and
- WHEREAS,** the Tribal Council recognizes Darvin Burnette's years of service to this Tribe, as an employee of the Tribe for many years and for his membership on the Tribal Council from 1986 through 1988; and
- WHEREAS,** Mr. Burnette also served his country as a member of the United States Army; and
- WHEREAS,** the Tribal Council, as a tribute to Darvin Burnette, wishes to assume costs of the funeral and burial, which includes the cost of the casket, headstone, fencing for the gravesite, flagpole, and a beef and groceries for the wake.


BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby offers its sincere sympathies to the family of Darvin Burnette in their time of sorrow.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby assumes costs of the wake, funeral and burial of former Tribal Councilmember Darvin Burnette, including the cost of the casket, headstone, fencing for the gravesite, flagpole, and a beef and groceries for the wake.

The foregoing resolution was on June 11, 1996, duly adopted by a vote of ten for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by the White Mountain Apache Tribal Constitution, including Article IV, Sections 1 (a), (h), (k), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe on September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
