

**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

WHEREAS, the Tribal Council has been advised that former Tribal Council member, Carlos Nosie passed away on Tuesday, July 30, 1996; and

WHEREAS, the Tribal Council extends its sincere sympathy to Mr. Nosie's family; and

WHEREAS, the Tribal Council recognizes Carlos Nosie's years of service to this Tribe, as an employee of the Tribe for many years and for his membership on the Tribal Council; and

WHEREAS, Mr. Nosie also served his country as a member of the United States Armed Forces; and

WHEREAS, the Tribal Council, as tribute to Carlos Nosie, wishes to assume all costs of the funeral and burial, including the cost of the casket, headstone, fencing for the gravesite, flagpole, and a beef for the wake.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby offers its sincere sympathies to the family of Carlos Nosie in their time of sorrow.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby assumes all costs of the funeral and burial of former Tribal Council member Carlos Nosie, including the cost of the casket, headstone, fencing for the gravesite, flagpole, and a beef for the wake.

The foregoing resolution was on July 31, 1996, duly adopted by a vote of eight for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by the White Mountain Apache Tribal Constitution, including Article IV, Sections 1 (a), (h), (k), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe on September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).

Signatures of the members of the Tribal Council represent their approval of Tribal Resolution No. 07-96-175.




