

**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

WHEREAS, District IV Tribal Council Member Frank Endfield has requested Tribal Council approval for two Sunrise ski trips for McNary Elementary students who are enrolled members of the White Mountain Apache Tribe and to pay for the two Sunrise ski trips with McNary Community Land Claims Funds; and

WHEREAS, supporting documentation and a petition to so use District IV McNary Land Claims Funds for McNary Elementary School students who are tribal members is attached to this resolution and incorporated by reference herein; and

WHEREAS, the Tribal Council concurs in the request.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the petition request from the McNary Community to utilize McNary Land Claims Funds from District IV to sponsor tribal member students from the McNary Elementary School to travel to Sunrise on two ski trips.

The foregoing resolution was on December 16, 1996, duly adopted by a vote of nine for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by the White Mountain Apache Tribal Constitution, including Article IV, Sections 1(a), (i), (k), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe on September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
