

**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

WHEREAS, the Tribal Council of the White Mountain Apache Tribe has been advised that Cheryl Minjarez has requested enrollment for her daughter with the White Mountain Apache Tribe; and

WHEREAS, a conditional relinquishment with the Ft. Peck Assiniboine and Sioux Tribes has been signed on December 12, 1995; and

WHEREAS, the Tribal Enrollment Committee has completely reviewed Jeanna Ricker's enrollment application, and all supporting documents; and

WHEREAS, the Enrollment Committee finds that Jeanna Ricker, whose birth date is March 10, 1984, possesses a blood quantum of one-fourth White Mountain Apache and one-half total Indian Blood; and

WHEREAS, the Enrollment Committee finds that Jeanna Ricker meets the blood quantum requirements set forth in the Constitution of the White Mountain Apache Tribe and is eligible for enrollment with the White Mountain Apache Tribe; and

WHEREAS, Jeanna Ricker has not received any Court of Claims judgment funds, and thus would be eligible for a per-capita distribution of the White Mountain Apache Tribe Docket 22-H funds.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby grants Jeanna Ricker membership into the White Mountain Apache Tribe based upon the recommendation of the Tribal Enrollment Committee, subject to the final execution of conditional relinquishment of membership from the Ft. Peck Assiniboine and Sioux Tribes and subject to rescission pursuant to the Tribal Enrollment Code Section 1-202 (c) and 1-704.


BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs the office of Vital Records to verify that Jeanna Ricker's membership in the Ft. Peck Assiniboine and Sioux Tribes has been fully and finally relinquished prior to adding her name to the enrollment records of the White Mountain Apache Tribe, and that if such relinquishment is not completed within sixty (60) days of the date of this resolution, the authorization granted in this resolution shall be void.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that pursuant to Resolution 04-96-085 and the Tribe's 22-H Distribution Plan, Jeanna Ricker shall be eligible to receive a distribution under Court of Claims case Docket 22-H, because Jeanna Ricker has not previously received Court of Claims funds while enrolled with any other Tribe.

The foregoing resolution was on August 22, 1997 duly adopted by a vote of eight for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
