RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

- WHEREAS, the Tribal Council of the White Mountain Apache Tribe has been advised that Trampus Colby has requested enrollment with the White Mountain Apache Tribe; and
- WHEREAS, the Tribal Enrollment Committee has completely reviewed Trampus Colby's enrollment application, and all supporting documents; and
- WHEREAS, the Enrollment Committee finds the Trampus Colby, whose birth date is April 9, 1983, possesses a blood quantum of one-half White Mountain Apache and four-fourths total Indian Blood; and
- WHEREAS, the Enrollment Committee finds that Trampus Colby meets the blood quantum requirements set forth in the Constitution of the White Mountain Apache Tribe and is eligible for enrollment with the White Mountain Apache Tribe; and
- WHEREAS, Trampus Colby was enrolled from birth with the Ft. McDermitt Paiute-Shoshone Tribe, until he relinquished his enrollment effective May 13, 1997; and
- WHEREAS, Trampus Colby has received a per-capita distribution under Court of Claims Docket 87-D, while enrolled with the Ft. McDermitt Paiute-Shoshone Tribe; and
- WHEREAS, pursuant to Resolution No. 04-96-085, which has been incorporated into the Tribe's 22-H Distribution Plan, Trampus Colby would be ineligible to receive a distribution under the White Mountain Apache Tribe judgment under its Court of Claims Case Docket 22-H.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby grants Trampus Colby's request for membership into the White Mountain Apache Tribe based upon the recommendation of the Tribal Enrollment Committee, and subject to recission pursuant to the Tribal Enrollment Code, Sections 1-202 C and 1-704.
- **BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that pursuant to Resolution No. 04-96-085 and the Tribe's 22-H Distribution plan, Trampus Colby shall be ineligible to receive a distribution under Court of Claims Case Docket 22-H, due to Trampus Colby's prior receipt of Docket 87-D funds while enrolled with the Ft. McDermitt Paiute-Shoshone Tribe.
