
**WHEREAS**, Raymus Albert advised to amend the minutes to delete #2 and #3 for further review and clarification.

**WHEREAS**, the Tribal Council is in agreement that the Land Board meeting minutes of December 18, 1998 should be approved with the exception of topics #2 & #3.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the Land Board meeting minutes as presented with the exception of topics #2 & #3.

The foregoing resolution was on January 7, 1999 adopted by a vote of nine for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (h), (i), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe on September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
