WHEREAS, Mr. Albert further requests the addition of Mr. Andy Bennett's land request for area across the Whiteriver Airport, as approved by the Land Board; and

WHEREAS, the Tribal Council, after review and discussion of the Land Board meeting minutes, is in agreement that the Land Board meeting minutes of July 30, 1999 should be approved.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the Land Board meeting minutes of July 30, 1999 as presented.

The foregoing resolution was on August 13, 1999, duly adopted by a vote of SEVEN for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (h), (i), (s), (t), and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1933 (48 Stat. 984).
