RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

- WHEREAS, tribal member Barbara (Harvey) Ratterree has come before the Tribal Council and advised that she has resided in the house located at 344 Oak Street in McNary, for the past eleven years; and
- WHEREAS, in 1990, Mrs. Ratterree was informed by the Tribal Safety Officer and McNary Housing Director, that the Tribe had condemned the home she was living in, and that as the new owner, she would now be responsible for future maintenance and repairs of the home; and
- WHEREAS, since 1990, she has invested a considerable amount of time and money in upgrading the home to make it safe and suitable for her and her family; and
- WHEREAS, Mrs. Ratterree has applied for a weatherization loan from Navopache Electric to replace the roof on her home, however, in order to qualify for the weatherization loan, Mrs. Ratterree must provide Navopache Electric with written documentation that she is the owner of the home; and
- WHEREAS, Mrs. Ratterree is requesting Tribal Council approval in granting her ownership of the home located at 344 Oak Street, in the McNary community.
- WHEREAS, the Tribal Council believes it would be in the best interest of Mrs. Ratterree to grant her ownership of the home as requested, with the understanding that this grant shall not include the land upon which the home is situated.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby grants ownership of the home located at 344 Oak Street in the Community of McNary, to tribal member Barbara (Harvey) Ratterree.
- BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that all rights, title and interest in the home is given to Barbara (Harvey) Ratterree as her sole property, with the understanding that the land upon which the house is situated shall remain in the name of the Tribe.
- BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes the Tribal Chairman, or in his absence the Vice Chairman or other duly authorized representative, to execute any and all documents necessary to carry out the intent of this resolution.

The foregoing resolution was on <u>April 6, 2000</u>, duly adopted by a vote of <u>SEVEN</u> for and <u>ZERO</u> against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1(a), (b), (h), (i), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18,1934 (48 Stat. 984).

I'VE SPENT A LOT OF MONEY AND TIME UPGRADING IT OVER THE LAST 10 YEARS, AND NOW NEED A RESOLUTION STATING IT IS MY HOUSE TO QUALIFY FOR A NEW ROOF THROUGH A"WEATHER-IZATION LOAN" FROM NAVOPACHE ELECTRIC WHERE I AM EMPLOYED.
