

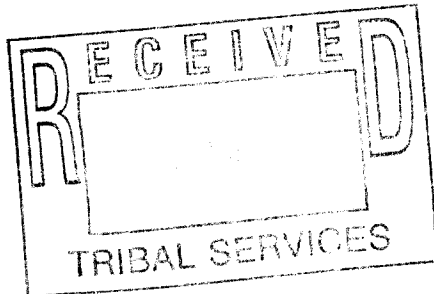
**RESOLUTION OF THE

FORT APACHE INDIAN RESERVATION**

WHEREAS, Raymus Albert, Director of the Land Office and Land Board Chairperson, has come before the Tribal Council this date requesting approval of the Land Board meeting minutes of March 31, April 28, and May 26, 2000; and

WHEREAS, the Tribal Council, after review of the Land Board meeting minutes, agrees that the Land Board meeting minutes of March 31, April 28, and May 26, 2000 should be approved as presented, but to table Mr. Johnny Cromwell's request for further clarification.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the Land Board meeting minutes of March 31, April 28, and May 26, 2000 as presented and to table Mr. Johnny Cromwell's request.

The foregoing resolution was on June 8, 2000, duly adopted by a vote of EIGHT for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (h), (i), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe on September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
