

**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

- WHEREAS,** *The Master Plan for the Fort Apache Historic Park*, along with subsequent planning documents and ongoing initiatives, has established an ambitious and far reaching vision for the reincorporation of the Fort Apache Historic District into the White Mountain Apache community through programs promoting community representation, economic development and cultural perpetuation; and
- WHEREAS,** the White Mountain Apache Tribe chartered the Fort Apache Heritage Foundation to provide conceptual, technical, and developmental guidance and leadership in making this vision into reality by putting Fort Apache back into service for the Apache people; and
- WHEREAS,** through the cooperation of the Foundation and the Tribe, as well as countless supporters and volunteers, last year the Tribe held the First Annual Fort Apache Reunion at the historic site of Fort Apache; and
- WHEREAS,** based upon the success and community interest from last year's event, the Fort Apache Board of Directors has issued a consensus recommendation to hold this event again this year on May 19, 2001, and to focus upon the same goals of community integration and fund raising effort in support of the Fort Apache vision, such event to be entitled *The Great Fort Apache Heritage Reunion 2001*; and
- WHEREAS,** Reunion plans call for a respectful healing ceremony, a processional parade, a series of living history displays and demonstrations, and the assembly of the diverse groups of students, veterans, Apache Scout families and cavalry groups associated with Fort Apache and the Theodore Roosevelt School; and
- WHEREAS,** this event embraces the overall goal of fostering the enthusiasm, support and participation of local, regional, national and international communities and partners in pursuit of the Tribe's vision for Fort Apache; and
- WHEREAS,** the Enterprise/Tourism Director and staff have outlined for the Council the plans to date for this event, and presented the budget for its completion.
- BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes and endorses Fort Apache Heritage Foundation plans for *The Great Fort Apache Heritage Reunion*, to be held on May 19, 2001

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that

it hereby authorizes the establishment of a collaborative coordinating committee to be headed by the Executive Director and staff of the Enterprise/Tourism Division to work in concert with the Foundation Directors and the following Tribal officials or their designees: Historic Preservation Officer, Heritage Program Director, Sunrise Resort Manager, Hon Dah Resort and Casino Manager, Healthy Nations Director, Public Works Director, Fair and Rodeo Manager, Police Chief, Public Relations Representatives, Superintendent of the Whiteriver Unified School District, the Superintendent of the Fort Apache BIA Agency and other Tribal Officials and Foundation designees, as appropriate.

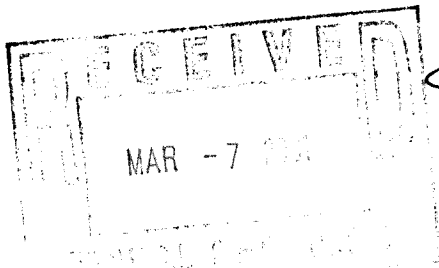
**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the event be planned and implemented to reunite the people in a constructive spirit of reconciliation, healing and mutual respect and affection, all parties and groups with enduring ties to and appreciation for Fort Apache.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Reunion be planned and implemented as the second in a long series of annual events designed to realize, expand and enhance the vision for Fort Apache.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Reunion be planned and implemented as a drug-, alcohol-, and violence-free event focused on the enduring qualities of peace, harmony, and good will.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the proposed budget for the event is approved and that the Enterprise/Tourism Division personnel are directed to meet with the Tribal Treasurer and Tribal Controller to identify a means of funding the approved budget.

The foregoing resolution was on February 28, 2001 duly adopted by a vote of SIX for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (h), (i), (k), (s), (t), and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
