WHEREAS, Council Member Margaret Baha-Walker has informed the Tribal Council that Annabelle Riley and family had incurred expenses at the Ronald McDonald House while their daughter, Tiffany Riley, was hospitalized; and

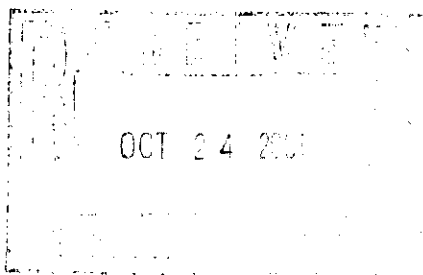
WHEREAS, the Riley family stayed at the Ronald McDonald House in Tucson, AZ from 2/14/01 through 6/28/01 and from 7/05/01 through 7/07/01 for a total of 136 nights and the usage fee is \$10.00 a night bringing the total bill to \$1,360.00; and


WHEREAS, the outstanding bill could not be paid by Tribal Social Services; and


WHEREAS, Council Member Margaret Baha-Walker requests that the Tribal Controller locate an account within the tribe from which the bill will be paid to alleviate the family's concern about the bill.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs the Tribal Controller to pay the Ronald McDonald House bill in the amount of \$1,360.00 for the Riley family from an account within the tribe.

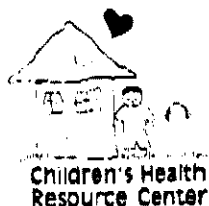
The foregoing resolution was on August 2, 2001, duly adopted by a vote of TEN for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (h), (k), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe on September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
