

**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

WHEREAS, the Tribal Election Commission has on this date presented to the Tribal Council its Certification of Candidates, attached hereto and incorporated by reference herein, for those candidates who under the standards established in the Tribal Constitution and Tribal Election Ordinance are qualified to be nominated for office in the upcoming primary and general election; and

WHEREAS, the Tribal Constitution and Tribal Election Ordinance require that the Tribal Council certify and declare that candidates for the office of Tribal Council have been regularly nominated and that each is a candidate for the office of Council member as indicated in the nomination petitions; and

WHEREAS, the Election Commission advises that each individual listed meets the criteria set forth in the Election Code and Constitution and therefore is qualified to be declared by the Council to have been regularly nominated as a candidate.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby certifies the candidates presented this date by the Tribal Election Commission as attached to this resolution and incorporated by reference herein.

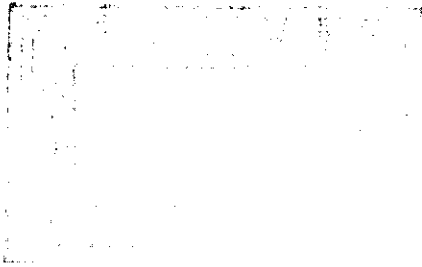
