

**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

WHEREAS, on March 21, 2002, the Tribal Council approved the relinquishment from membership in the Tribe for the following tribal members:

WHEREAS, the relinquishment was requested to allow the members to enroll with the Salt River Pima Maricopa Indian Community ("SRPMIC"); and for that reason the relinquishment was conditioned upon the final enrollment by the individuals into the membership of SRPMIC; and

WHEREAS, the Council is now advised that the enrollment into SRPMIC cannot be completed because of the relinquishment from the White Mountain Apache Tribe was conditional, and for purposes of enrollment with SRPMIC, the relinquishment must be complete and unconditioned; and

WHEREAS, the six individuals have requested unconditional relinquishment of membership in the White Mountain Apache Tribe in order to complete their enrollment with SRPMIC.


BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby grants the tribal membership relinquishment requests of these individuals, and their tribal membership with the White Mountain Apache Tribe is relinquished, along with any and all privileges accorded members of the White Mountain Apache Tribe such as, but not limited to hunting, fishing, and recreational privileges on the White Mountain Apache Indian Reservation.

BE IT FURTHER RESOLVED by the Tribal Council that it hereby directs the Office of Vital Records to remove these individuals from the membership rolls of the White Mountain Apache Tribe.


The foregoing resolution was on June 5, 2002 duly adopted by a vote of SEVEN for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by the White Mountain Apache Tribal Constitution, including Article II, Section 2 of the

Resolution No. 06-2002-105

Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
