WHEREAS, the Tribal Council has been advised that Tribal member Helen Crocker passed away on Saturday, December 28, 2002; and

WHEREAS, the Tribal Council extends its sincere sympathy to Mrs. Crocker's family; and

WHEREAS, the Tribal Council recognizes Helen Crocker's many years of service to this Tribe, through a lifetime of activities and achievements, her contributions to the youth of the White Mountain Apache Tribe as a teacher of the Apache Culture and consulting with the Tribal programs is greatly appreciated and remembered; and

WHEREAS, Helen Crocker gave years of service to this Tribe, as a long-term Tribal employee; and

WHEREAS, the Tribal Council, as a tribute to Helen Crocker, wishes to assume the remaining costs of the funeral in the amount of \$2,400.00.


BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby offers its sincere sympathies to the family of Helen Crocker in their time of sorrow.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby assumes the remaining funeral costs of \$2,400.00 for Helen Crocker.

The foregoing resolution was on January 02, 2003 duly adopted by a vote of SEVEN for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (h), (k), (s), (t), and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).





Chairman of the Tribal Council


