

**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

WHEREAS, tribal member Travis Thomas, dob: 10/23/1975, son of Frederick P. Thomas, Sr. and Linda Sue (Griggs) Thomas, has requested that his tribal membership with the White Mountain Apache Tribe be relinquished so that he may become eligible for enrollment with the Salt River Pima-Maricopa Indian Community; and



WHEREAS, the necessary documents for relinquishment of head rights was signed by Travis Thomas in the presence of a Notary Public on the 26th day of August, 2003, and are attached hereto; and

WHEREAS, the Tribal Enrollment Committee approved this relinquishment request at their meeting on September 5, 2003.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby grants the tribal relinquishment request of Travis Thomas and his tribal membership with the White Mountain Apache Tribe is relinquished, along with any and all privileges accorded members of the White Mountain Apache Tribe such as, but not limited to: hunting, fishing, and recreational privileges upon the White Mountain Apache Indian Reservation.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs the Office of Vital Records to remove Travis Thomas from the membership rolls of the White Mountain Apache Tribe.

The foregoing resolution was on September 9, 2003, duly adopted by a vote of SIX for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by the White Mountain Apache Tribal Constitution, including Article II and Article IV, Section I (a), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe on September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

**RELINQUISHMENT OF TRIBAL HEAD RIGHTS
WHITE MOUNTAIN APACHE TRIBE
FORT APACHE INDIAN RESERVATION**

I, TRAVIS THOMAS, an enrolled member of the WHITE MOUNTAIN APACHE TRIBE, do hereby of my own free will, as an adult over the age of 18 years, voluntarily and with full knowledge of making this decision, request the TRIBAL COUNCIL of the WHITE MOUNTAIN APACHE TRIBE, FORT APACHE INDIAN RESERVATION, WHITERIVER, ARIZONA, to remove me from the Tribal Census Rolls of the White Mountain Apache Tribe to enable me to enroll with the SACTIVER - White Mountain.

Further, I understand that once my relinquishment is accepted by Tribal Council Resolution, it will be total and irrevocable. I will no longer have fishing or hunting privileges on the Fort Apache Indian Reservation; no rights to homesite or farmland assignments, claim or title to any resources of the WHITE MOUNTAIN APACHE TRIBE, or monies distributed pursuant to Judgement under the Indian Claims Commission Act. Further, that I must remove from the Fort Apache Indian Reservation within ninety (90) days after the resolution date accepting my relinquishment, all my livestock and personal property.

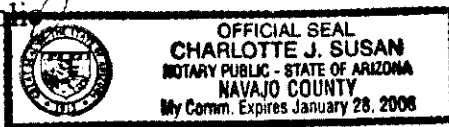
