

**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

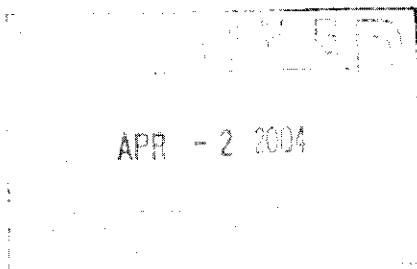
**WHEREAS**, the Tribal Council of the White Mountain Apache Tribe has been advised that Blessing Joy Cooley is requesting enrollment with the White Mountain Apache Tribe.

**WHEREAS**, the Tribal Enrollment Committee has completely reviewed Blessing Joy Cooley enrollment application, whose birth date is February 14, 2003 with supporting required documents; and

**WHEREAS**, the Enrollment Committee finds Blessing Joy Cooley possesses the necessary blood quantum required under the Tribal Constitution and Enrollment Code.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby grants Blessing Joy Cooley membership with the White Mountain Apache Tribe based on the recommendation of the Tribal Enrollment Committee, subject to rescission pursuant to the Tribal Enrollment Code, Sections 1-202@ and 1-704.

The foregoing resolution was on 03/11/04 duly adopted by a vote of 7 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article II, Section 1 of the White Mountain Apache Tribal Constitution, ratified by the Tribe on September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).





