

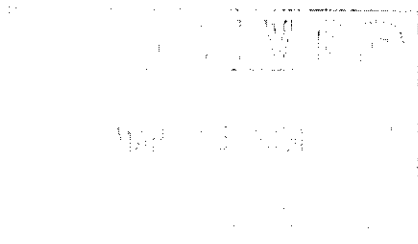
**RESOLUTION OF THE


**WHEREAS,** the Tribal Council, after review of the Land Board meeting minutes, agree that item #6 for farmland application and relinquishment be tabled until a review is done by the Livestock Association and the community, and that the Land Board meeting minutes for January 29, 2004 should be approved with the exceptions mentioned above.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the Land Board meeting minutes for January 29, 2004 as presented.

The foregoing resolution was on March 18, 2004 duly adopted by a vote of NINE for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (h), (i), (s), (t), and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
