WHEREAS, the Tribal Wildlife & Outdoor Recreation Division has come before the Tribal Council this date and requested approval of the Non-tribal Member Hunting Regulations for 2004-2005, copies of which are attached hereto; and


WHEREAS, the Tribal Council has reviewed recommended changes to the Non-tribal Member Hunting Regulations designed to provide sustainable management of Tribal wildlife resources; and


WHEREAS, the hunting seasons, bag limits and regulations are based on sound biological principle, surveys and methods; and

WHEREAS, the Tribal Council concludes that the Non-tribal Member Hunting Regulations for 2004-2005, as amended herein, be approved by the Tribal Council.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the attached Non-tribal Member Hunting Regulations for 2004-2005, as amended herein.

The foregoing resolution was on JUNE 3, 2004 duly adopted by a vote of NINE for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (f), (h), (s), (t), and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
