- **WHEREAS**, the necessary documents of relinquishment of heard rights was signed by Norman Talkalai in the presence of a Notary Public on the 16th day of March 2004 and are attached hereto; and
- **WHEREAS**, the Tribal Enrollment Committee approved this relinquishment request at their meeting on May 12, 2004.
- grants the tribal relinquishment request of Norman Talkalai, and his tribal membership with the White Mountain Apache Tribe is relinquished, along with any and all privileges accorded members of the White Mountain Apache Tribe such as, but not limited to hunting, fishing, and recreational privileges upon the White Mountain Apache Indian Reservation and upon the Office of Vital Records' receipt of Proof of Enrollment with the San Carlos Apache Tribe
- **BE IT FURTHER RESOLVED** by the Tribal Council that it hereby directs the Office of Vital Records to remove Norman Talkalai from the membership rolls of the White Mountain Apache Tribe upon verification of her enrollment with the San Carlos Apache Tribe.

The foregoing resolution was on <u>June 3</u>, <u>2004</u>, duly adopted by a vote of SEVEN for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article II, Section 2 and Article IV, Section 1 of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

I will no longer have fishing or hunting privileges on the Fort Apache Indian Reservation; no rights to homesite or farmland assignments, claim or title to any resources of the WHITE MOUNTAIN APACHE TRIBE, or monies distributed pursuant to Judgement under the Indian Claims Commission Act. Further, that I must remove from the Fort Apache Indian Reservation within ninety (90) days after the resolution date accepting my relinquishment, all my livestock and personal property.
