**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**WHEREAS,** Mrs. Melissa Riley Tortes, a parent of tribal member Kristiana Shawn-Marie Tortes, date of birth: 09/21/97, has requested that Kristiana's tribal membership with the White Mountain Apache Tribe be relinquished so that she may become eligible for enrollment with the Torres-Martinez Reservation; and

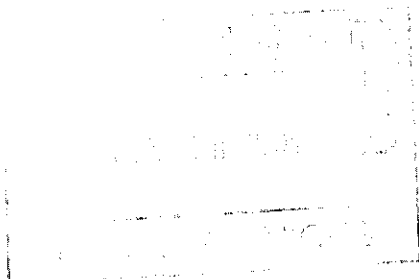
**WHEREAS,** the necessary documents of relinquishment of heard rights was signed by Melissa Riley Tortes in the presence of a Notary Public on the 25<sup>th</sup> day of February 2004 and are attached hereto; and

**WHEREAS,** the Tribal Enrollment Committee approved this relinquishment request at their meeting on May 12, 2004.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby grants the tribal relinquishment request of Kristiana Shawn-Marie Tortes, and her tribal membership with the White Mountain Apache Tribe is relinquished, along with any and all privileges accorded members of the White Mountain Apache Tribe such as, but not limited to hunting, fishing, and recreational privileges upon the White Mountain Apache Indian Reservation and upon the Office of Vital Records' receipt of Proof of Enrollment with the Torres-Martinez Reservation.

**BE IT FURTHER RESOLVED** by the Tribal Council that it hereby directs the Office of Vital Records to remove Kristiana Shawn-Marie Tortes from the membership rolls of the White Mountain Apache Tribe upon verification of her enrollment with the Torres-Martinez Reservation.

The foregoing resolution was on June 3, 2004, duly adopted by a vote of SEVEN for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article II, Section 2 and Article IV, Section 1 of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

**RELINQUISHMENT OF TRIBAL HEAD RIGHTS  
WHITE MOUNTAIN APACHE TRIBE  
FORT APACHE INDIAN RESERVATION**

I, MELISSA RIEU TORRES the parent of our child who is an enrolled member of the WHITE MOUNTAIN APACHE TRIBE, under the age of 15 years, do hereby, of my/our own free will, as an adult over the age of eighteen years, voluntarily and with full knowledge of making this decision, request the TRIBAL COUNCIL of the WHITE MOUNTAIN APACHE TRIBE, FORT APACHE INDIAN RESERVATION, WHITERIVER, ARIZONA, to release my/our child from the Tribal Census Rolls of the White Mountain Apache Tribe to enable my/our child to enroll with the Torres-Martinez Reservation

Further, I/WE understand that my/our child will no longer have fishing or hunting privileges on the FORT APACHE INDIAN RESERVATION; No homesite or farmland assignments, or claim to have titles to any resources of the WHITE MOUNTAIN APACHE TRIBE, or monies distributed pursuant to Judgement under the Indian Claims Commission Act. Further, that I must remove from the Fort Apache Indian Reservation within ninety (90) days after the Resolution date accepting my/our child's relinquishment, any livestock in said child's name. I further understand, however, that my child may reapply for enrollment in the White Mountain Apache Tribe upon reaching the age of eighteen (18), but that the Tribal Council has total, nonreviewable discretion to deny or grant said reapplication.
