**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**WHEREAS,** the Committee Members for Miss White Mountain Apache Queen were selected in December 2003; and

**WHEREAS,** the Queen Committee was informed that the Miss White Mountain Apache Queen and Princess Committee, historically, have received a budget of \$6,000.00 annually from the White Mountain Apache Tribe; and

**WHEREAS,** the Queen Committee has not expended any Tribal funds from the current committee's budget from the committee's inception to date; and

**WHEREAS,** the current Queen Committee's Tribal budget is \$1,668.00 according to Tribal accounting; and

**WHEREAS,** the 2004 Queen Committee hereby requests from the White Mountain Apache Tribal Council the difference of \$4,332.00 to make a total budget of \$6,000.00.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby awards the 2004 Queen Committee the amount of \$4,332.00 for a total budget of \$6,000.00 to cover expenses for two pageants: 2005 Miss White Mountain Apache Queen and 2005 Miss White Mountain Apache Princess.

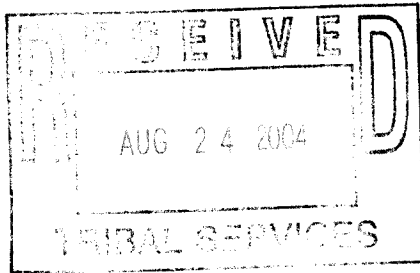
**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the approved budget will cover:

- Rental fees for Chief Alchesay Activity Center: \$500 deposit
- Activity Center Security: \$15/hour
- Light & Sound Rental Charges:
- Master/Mistress of Ceremonies:
- Entertainment: \$1,377.00
- Programs and Advertising: \$1,000.00
- Trophies/Plaque Awards to be purchased from High Country Awards:
- Rose Bouquets:
- Award Banners:

  - 500.00 First Attendant
  - 300.00 Second Attendant
  - 200.00 Princess

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that all proceeds from the two events will be used to cover the above expenses and the difference will be deposited in the same account within two (2) business days after the event.

The foregoing resolution was on AUGUST 4, 2004 duly adopted by a vote of SEVEN for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (s), (t), and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
