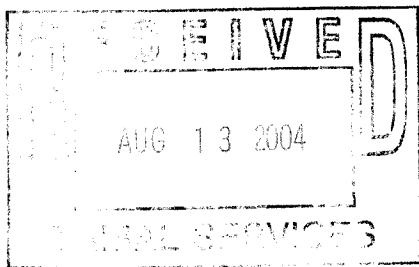


**WHEREAS,** the hunting seasons, bag limits and regulations are based on sound biological principle, surveys and methods; and


**WHEREAS,** the Tribal Council concludes that the Tribal Member Hunting Regulations for 2004-2005, as amended herein, be approved by the Tribal Council.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the attached Tribal Member Hunting Regulations for 2004-2005, as amended herein.

The foregoing resolution was on AUGUST 5, 2004 duly adopted by a vote of SIX for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (f), (h), (s), (t), and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
