RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

(Omnibus Resolution to correct a technical deficiency to the FY 2004 HUD Indian Community Development Block Grant that the Tribal Council previously approved.)

- WHEREAS, the Tribe in Resolution No. 11-2004-264 estimated that the cost to operate and maintain the Adult Detention and Rehabilitation Center is \$72,520; and
- WHEREAS, the Tribal Resolution No. 11-2004-264 committed \$65,000 to maintain the Tribe's Adult Detention and Rehabilitation Center; and
- WHEREAS, the White Mountain Apache Tribe will increase the amount of Tribal funds it will use to maintain and operate the Adult Detention and Rehabilitation Center from \$65,000 to \$72,520; and
- **BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby commits \$72,520 in Tribal funds to maintain and operate the new Tribal Adult Detention and Rehabilitation Center.

The foregoing resolution was on March 29,2005, duly adopted by a vote of SIX for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (b), (c), (h), (i), (j), (k), (l), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
