(Approval to grant tribal relinquishment request of Juanita (Wilson) Joe)

- WHEREAS, Tribal member Juanita (Wilson) Joe, date of birth: 01/26/1970, daughter of Calvin & Abigail (Tortice) Wilson, has requested that her tribal membership with the White Mountain Apache Tribe be relinquished so that she may become eligible for enrollment with the Salt River Pima-Maricopa Indian Community; and
- WHEREAS, the necessary document of relinquishment of head rights was signed by Juanita (Wilson) Joe in the presence of a Notary Public on the 19th day of January 2005 and is attached hereto; and
- **WHEREAS**, the Tribal Enrollment Committee approved this relinquishment request at their meeting on April 6, 2005.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby grants the tribal relinquishment request of Juanita (Wilson) Joe, and her tribal membership with the White Mountain Apache Tribe is relinquished, along with any and all privileges accorded members of the White Mountain Apache Tribe such as, but not limited to hunting, fishing, and recreational privileges upon the White Mountain Apache Indian Reservation.
- **BE IT FURTHER RESOLVED** by the Tribal Council that it hereby directs the Office of Vital Records to remove Juanita (Wilson) Joe from the membership rolls of the White Mountain Apache Tribe.

The foregoing resolution was on <u>April 13, 2005</u>, duly adopted by a vote of <u>SEVEN</u> for and <u>ONE</u> against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article II, Section 2 and Article IV, Section 1 of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

Further, I understand that once my relinquishment is accepted by Tribal Council Resolution, it will be **TOTAL AND IRREVOCABLE**. I will no longer have fishing or hunting privileges on the Fort Apache Indian Reservation; no rights to homesite or farmland assignments, claim or title to any resources of the WHITE MOUNTAIN APACHE TRIBE, or monies distributed pursuant to Judgment under the Indian Claims Commission Act. Further, that I must remove from the Fort Apache Indian Reservation within ninety (90) days after the resolution date accepting my relinquishment, all my livestock and personal property.
