

**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**(Approving grant application to the Oversight Council on Driving or Operating  
Under the Influence Abatement)**


**WHEREAS**, the White Mountain Apache Tribe is concerned over the high rate of motor vehicle crashes reported and the increasing numbers of fatalities involving tribal members, a large percentage stemming from alcohol usage; and


**WHEREAS**, the White Mountain Apache Tribe and the White Mountain Apache Police Department is interested in developing within the Police Department, a Traffic Services Unit that will concentrate on highway patrols, DUI detection and prevention, and otherwise a more visible patrol on the reservation highway systems, and also to develop their Records Management System whereby accurate records of all types of incidents, including, but not limited to, traffic accidents, to assist the tribal government in improving the lives and safety of the residents; and

**WHEREAS**, the Oversight Council on Driving and Operating Under the Influence Abatement has grant funds available to assist local governments on detection, prevention, and improving law enforcement response to curb the incidents involving alcohol abuses and motor vehicle operations and the White Mountain Apache Police Department is interested in the implementation of a traffic services unit for this purpose, given the statistics on the number of such incidents resulting in fatalities, and the White Mountain Apache Tribe hereby agrees to use the funding only for the intended purpose established for this grant application.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the proposed grant application to the Oversight Council on Driving or Operating Under the Influence Abatement and authorizes the Tribal Chairman to sign all authorizations and the Chief of Police to manage the project.






