**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

(Approval of back pay request for Tribal Member Wyleen Sanchez)

WHEREAS, Ms. Wyleen Sanchez has come before the Tribal Council this date to request back pay; and

WHEREAS, Ms. Sanchez was reinstated to her position at the Tribal Gaming Office per the decision of the Tribal Grievance Committee; and


WHEREAS, Ms. Sanchez is requesting back pay in excess of the two pay periods as per Tribal Resolution No. 01-2003-13; and


WHEREAS, the amount requested is \$3,923.50, which is the difference between Tribal Gaming and Housing Authority hours as per the attached; and

WHEREAS, verification by Tribal Personnel Department found that the correct amount should be \$3,863.50.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves Wyleen Sanchez' back pay request in the amount of \$3,863.50 as verified by Tribal Personnel Department.

The foregoing resolution was on April 6, 2005, duly adopted by a vote of NINE for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 ((a), (h), (i), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

Alex Ritchie, Tribal Attorney informed my department that you were requesting a back pay from Tribal Gaming Office in the amount of \$3,923.50 for time lost at work due to termination. Mr. Ritchie requested that we check all calculations and verify with Housing Authority regarding your actual work hours. Upon completion of Mr. Ritchie's request we have determine that the total amount due to you is \$3,863.50. If you wish to contest this amount please provide all documentation to justify the amount of \$3,923.50, your original request. As result of this, I have notified Mr. Connelly, Executive Director, and informed him that the amount of your back pay should be in the amount of \$3,863.50. However, should you provide justification for the amount of \$3,923.50 we would consider reimbursement for the difference.
