WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

(To approve financial assistance for the Rezzrunners/Rez Girls Basketball teams)


- WHEREAS,** John Andreas, Jr., coach for the above-mentioned teams, along with some members of the teams, appeared before the Tribal Council this date; and
- WHEREAS,** Mr. Andreas thanked the Tribal Council for their recent financial support when they participated in Native American Basketball Tournament; and
- WHEREAS,** Mr. Andreas informed the Tribal Council of upcoming basketball tournaments that the teams will be participating in from July 7 through August 1, 2005 in California; and
- WHEREAS,** a majority of the costs associated with this travel will be assumed by Mr. Andreas, however, any help will be appreciated.


WHEREAS, the Tribal Council agrees to assist the teams with \$6,000.00 for their hotel rooms.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves a grant of \$6,000.00 for its young tribal members to participate in basketball tournaments in California from July 7 through August 1, 2005..

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby designates that the funds be appropriated from the Tribal Contributions Account.

The foregoing resolution was on July 6, 2005, duly adopted by a vote of TEN for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (i), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

My Rezrunners will be departing Whiteriver Thursday the 7th of July for a three week stay at Palm Springs California. On July 8th , 9th and 10th the rezrunners will be attending a CIF basketball tournament. They will also be competing on the 15th , 16th and 17th of July at the same location.

My Rez Girls will be arriving in Anaheim on July 15th and competing in a tournament through July 19th.

We are then headed to San Diego where the Rez Girls will be competing in the San Diego Classic at San Diego State University on July 20th - 24th.

I am then taking my kids back to Los Angeles where My wife and I will be taking all the kids to Magic Mountain on July 25th.

The girls will then head back to Whiteriver on July 26th and the boys will be competing once again at Palm Springs on July 29th, 30th and 31st. We will then head back to Whiteriver on August 1st.

We have a total of 7 players, 4 nephews and my daughter Angie who will be departing tomorrow morning at 8am.

That's a total of 12 people for ten days at the spa and resort, we need a total of 3 rooms @ \$75.00 for 10 days, that's a total of \$2,250.00.

My girls need 3 rooms @ \$99.00 arriving on July 15th and departing Anaheim on July 20th, for a total of \$1,500.00 dollars.

When my rezrunners arrive in Anaheim on the 17th of July after their Palm Springs tournament I will be picking up the cost of their stay which is \$900.00 dollars.

We will then travel to San Diego arriving on the 20th and departing on the 24th, my Rez Girls need 3 rooms @ \$99.00 for a total of \$1,200.00, I will be picking up the cost of the Rezrunners rooms for the same amount.


We then head to Magic Mountain where I will pick up the entire cost. My girls head home on the 26th and the boys arrive in Palm Springs on the 26th for their last basketball tournament of the summer, we depart on August 1st.

We need a total of 3 rooms @ \$75.00 dollars for 6 days at a total of \$1,350.00 dollars. The grand total for rooms on this summer trip is \$6,775.00.

We have no sponsors at this time and I am asking for help with the hotel cost. I have already paid \$2,130 dollars on the entry fee. I am picking up the cost of the travel and food, I am also picking up the cost for Magic Mountain. I am only asking for the rooms during our tournaments and am picking up the cost for my boys stay during the girls tournament. Anything you can help us out with is appreciated.

Most of these kids have never left the state of Arizona and this is a great opportunity for them to see the outside of the rez and so sharpen their skills for the upcoming Alchessay season, also helps these kids stay off drugs and away from drinking during these weekends.
