

**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

(Approval to grant tribal relinquishment request of David Howard Aguino, Jr.)

WHEREAS, Tribal member David Howard Aguino, Jr., date of birth: 11/21/1974, son of David Howard Aguino, Sr. and Neysa C. Lupe, has requested that his tribal membership with the White Mountain Apache Tribe be relinquished so that he may become eligible for enrollment with the San Juan Pueblo; and


WHEREAS, the necessary document of relinquishment of head rights was signed by David Howard Aguino, Jr. in the presence of a Notary Public on the 27th day of June 2005 and is attached hereto; and

WHEREAS, the Tribal Enrollment Committee approved this relinquishment request at their meeting on July 5, 2005.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby grants the tribal relinquishment request of David Howard Aguino, Jr. and his tribal membership with the White Mountain Apache Tribe is relinquished, along with any and all privileges accorded members of the White Mountain Apache Tribe such as, but not limited to hunting, fishing, and recreational privileges upon the White Mountain Apache Indian Reservation.

BE IT FURTHER RESOLVED by the Tribal Council that it hereby directs the Office of Vital Records to remove David Howard Aguino, Jr. from the membership rolls of the White Mountain Apache Tribe.

The foregoing resolution was on July 20, 2005, duly adopted by a vote of SIX for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article II, Section 2 and Article IV, Section 1 of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

RELINQUISHMENT OF TRIBAL HEAD RIGHTS
WHITE MOUNTAIN APACHE TRIBE
FORT APACHE INDIAN RESERVATION

I, David Howard Aguiño, JR., an enrolled member of the WHITE MOUNTAIN APACHE TRIBE, do hereby of my own free will, as an adult over the age of 18 years, voluntarily and with full knowledge of making this decision, request the TRIBAL COUNCIL of the WHITE MOUNTAIN APACHE TRIBE, FORT APACHE INDIAN RESERVATION, WHITERIVER, ARIZONA, to remove me from the Tribal Census Rolls of the White Mountain Apache Tribe to enable me to enroll with the San Juan Pueblo.

Further, I understand that once my relinquishment is accepted by Tribal Council Resolution, it will be **TOTAL AND IRREVOCABLE**. I will no longer have fishing or hunting privileges on the Fort Apache Indian Reservation; no rights to homesite or farmland assignments, claim or title to any resources of the WHITE MOUNTAIN APACHE TRIBE, or monies distributed pursuant to Judgment under the Indian Claims Commission Act. Further, that I must remove from the Fort Apache Indian Reservation within ninety (90) days after the resolution date accepting my relinquishment, all my livestock and personal property.
