

RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

(Granting ownership and title of the Tribal Rental Housing Unit #18 to tribal member Irene Endfield)

WHEREAS, Tribal member Irene Endfield has requested that the Tribal Council assign her the Tribal housing unit described as Tribal Rental Housing Unit #18; and

WHEREAS, Ms. Endfield was advised to move into unit house #18 although maintenance repairs were not completed and has lived there since June/July of 2000; and

WHEREAS, Ms. Endfield was further advised that repairs will follow but this never occurred; and

WHEREAS, the following maintenance issues were never addressed:

- 1. Bathroom sink does not drain and medicine cabinet needs to be replaced.
- 2. Kitchen sink pipes need to be fixed. Pipes still extend from the inside sink area through side of the house draining water under the house which attracts water snakes and other insects.
- 3. Laundry room drain pipes do not drain; washer drain pipes extend out window and water runs under the house which leads to same problem as #2.
- 4. House heater thermostat does not operate.
- 5. Other unfinished work within house; and

WHEREAS, due to the fact that the above maintenance repairs were never addresses, Ms. Endfield is requesting ownership and title of Tribal Rental Housing Unit #18.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that:

- 1. Ownership and title of the Tribal Rental Housing Unit #18 at North Upper Terrace Avenue hereby granted to Tribal member Irene Endfield.
- 2. As a condition of this transfer of ownership, Ms. Endfield shall be responsible for securing a land assignment or residential lease for Tribal Rental Housing Unit #18, and Ms. Endfield is prohibited from selling said home for a period of three years from the date of this Resolution.
- 3. The Legal Department is hereby directed to prepare transfer of ownership documents which relieves the Tribe of any further responsibility for maintenance and repair of said home.

4. The Tribal Chairman, or in his absence, the Vice Chairman, and any other officials designated by the Chairman, are hereby authorized to sign any documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on October 5, 2005, duly adopted by a vote of SEVEN for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (h), (k), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
