RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

- (Appropriating \$187,000.00 from the Rodeo-Chediski Fund to fund IHS Project PH04-C78 in Carrizo for on-site water collection, treatment and main extension)
- WHEREAS, pursuant to Section 1(a) of the Constitution of the White Mountain Apache Tribe, inter alia, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and
- WHEREAS, the U.S. Indian Health Service(IHS) has initiated a project for the White Mountain Apache Housing Authority (WMAHA) known as the Carrizo Water Main Extension, Wastewater Collection System and Wastewater Treatment Facility (PH04-C78, EA02-05), which was supported by Resolution No. 08-2004-172; and
- WHEREAS, the IHS has notified the WMAHA that the amount of funding for the off-site wastewater facilities in Carrizo, appropriated by the IHS in the amount of \$350,000.00, would not be sufficient to include the on-site facilities requested by the WMAHA, and that the IHS would require \$187,000.00 in additional funds from the Tribe to complete the project; and
- WHEREAS, the IHS has provided a budget for the increase via a letter dated October 24, 2005, as attached and incorporated by this reference; and
- WHEREAS, the IHS further requests that the increase be accomplished through an amendment to the Memorandum of Agreement for the project; and
- WHEREAS, the WMAHA has this day requested that the Tribal Council fund the on-site facilities in the amount of \$187,000.00; and
- WHEREAS, the Tribal Council finds that the on-site facilities for IHS Project No. PH04-C78 is in the best interests of the Carrizo community and the Tribe, and that sufficient funds are available in the Rodeo-Chediski fund.

BE IT RESOLVED by the White Mountain Apache Tribal Council that:

- 1. An amendment to the Memorandum of Agreement for IHS Project PH04-C78 is hereby approved for the purposes of including on-site facilities requested by the WMAHA at a cost of \$187,000.00 to the Tribe.
- 2. The amount of \$187,000.00 is hereby appropriated for expenditure according to the budget provided by the IHS, as attached and incorporated by this reference.
- 3. The Chairman, or in his absence the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.
