

RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

(Approving Proposal for Education Contract Pursuant to P.L. 93-638)

- WHEREAS, the Tribal Council of the White Mountain Apache Tribe is the governing body of the White Mountain Apache Tribe; and
- WHEREAS, the Tribal Council desires to recontract the Higher Education Grant, Johnson O'Malley Supplemental funds, Adult Vocational Training Grant, and the Adult Education Grant from the Bureau of Indian Affairs; and
- WHEREAS, the Tribal Council desires to contract for these programs on a yearly basis; and
- WHEREAS, the P.L. 93-638 Education Program contracts have, in the past, been successfully administered by the Tribe; and
- WHEREAS, the Tribal Council has authorized the Tribal Education Director to develop, plan, negotiate, and administer the Contract and/or any amendment therefore; and
- WHEREAS, the authority granted under this resolution to the Tribal Education Director is to run concurrent with the term of an annual contract pursuant to the Tribal Resolution Nos. 86-408 and 08-2004-183; and
- WHEREAS, the Tribal Council finds that the proposal is in the best interests of education on the Fort Apache Indian Reservation and the Tribe.
- **BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Tribal Education Director is hereby authorized to plan, develop, negotiate, and administer the Grants and Education Funds and Contracts discussed herein.
- BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Tribal Chairman and/or in his absence, the Vice-Chairman are authorized and directed to sign the contract for the following programs: (1) Higher Education; (2) Johnson O'Malley Program, (3) Adult Vocational Training; and (4) Adult Education (GED).
- **BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby approves and authorizes annual contracts in the above-mentioned programs; and in all 638 contracts negotiated subsequent to this date.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it makes all 638 contracts annual contracts, covering October 1, 2005 to September 30, 2006, to coincide with the Federal Government's fiscal year.

The foregoing resolution was on November 30, 2005, duly adopted by a vote of <u>SEVEN</u> for and <u>ZERO</u> against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (i), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
