**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**(Approving an Office Lease Agreement for the White Mountain Apache Tribal Court)**

**WHEREAS**, pursuant to the Constitution of the White Mountain Apache Tribe, the Tribal Council is empowered to negotiate, make and perform agreements of every description; and


**WHEREAS**, the White Mountain Apache Tribal Court was destroyed by fire and requires a new location to perform its functions; and

**WHEREAS**, the Tribe's Housing Authority is willing to lease that certain Whiteriver Ben Gay Housing Building to the Tribal Court for one year with a right to renew for another year, at the monthly rate of \$500.00, provided the Tribe sign an Office Lease Agreement; and

**WHEREAS**, the Tribal Council believes that it is in the best interest of the Tribe to relocate the Tribal Court to said building and enter into the Office Lease Agreement.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby approves an Office Lease Agreement by and between the Tribe's Housing Authority and the Tribe to enable the Tribal Court to relocate to the Whiteriver Ben Gay Housing Building and authorizes the Chairman or his authorized representative to sign any and all documents needed to effectuate the intent of this Resolution.


The foregoing resolution was on January 20, 2006, duly adopted by a vote of SIX for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe on September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




