FORT APACHE INDIAN RESERVATION**


(Approval of Land Board meeting minutes for February 23, 2006)



Members Present: Justin Williams, Board President, Pedro Johnson, Member, Rachel Endfield, Member.

Meeting opened in prayer by Pedro Johnson at 9:30.

1. **Otis Rico** – Requesting for Land in East Fort near the Rodeo Grounds. Board approve the request.
2. **Rhodesia Harvey** – Requesting land in Alchesay Flats for her 5 Children. She wants a land where all the children can build near one another. McDaniel suggested that she go to the Stock Association and make a request to them. Justin informed her that the children that are 18 and older need to put in an application themselves. She was given applications for her children.
3. **Sheila Pope** – Came before the board on concerns of her late Grandmother's (Deloris Pope) land in Seven Mile. The family heard that the Tribe are wanting to build apartments on their land. She claims that the land is all fenced in and pieces are relinquished to different members of the family. She asked if possible they could put Carrie Johnson, which is the oldest in the family, her name would be put in the rest of the land that is left. The original land assignment application was not in the file, Raymus informed the board that it was probably done thru council and was never filed with the Land Office. The land totals to 8 acres, more or less and there are 6 children, so the board advised that the land should be subdivide. The Board suggested to Sheila since she is a Granddaughter she really can't do anything on this and that the family will need to come together and come to a decision to clarify this matter. Sheila also had questions on the 3 farmlands her grandmother had. Raymus informed her that he will do a research on this and will let them know when they come at the meeting.
4. **Tremaine Benally** – Requesting for land in Whiskey Flats, which belong to her late mother. She came before the land board in January meeting and was told to get her brothers signatures for approval. She brought her application back and have their signatures. Board approved the request.
5. **Christine Gregg March** – Requesting for land in Cibecue, in the Red dust area. Board approve the request. McDaniel to check it out.
6. **Housing Authority** – Requesting for land totaling 191 acres in Hondah to build apartments.. Board approved.
7. **Marvalynn Walters** – Requesting for land in Hondah area. Board approved.
8. **Marleena Walters** – Requesting for land in Hondah area. Board approved.
9. **Karmalynn Walters** – Requesting for land in Hondah. Board approved.
10. **Chrystie Damon** – Relinquishing land site in Hondah back to the Tribe. Board approved

11. **Mary Ivins** – Updating application on her land in Seven Mile. Board Approved.
12. **Jimmy Lavender** – Updating application on his land in Diamond Creek. Board approved.
13. **Steve Dude** – Came before the board in January meeting requesting an additional land to his present site in Whiskey Flats. At that time he was told that McDaniel would survey it. McDaniel check into this request and found that he needed a recommendation from the Hydrologist. On February 22, the Hydrologist Cheryl Pailzote, responded on a letter to the Board stating that the she doesn't approve of the request due to the site being too narrow and fill material will be needed for the trailer to be leveled, and the site is adjacent to the hill with most of the runoff flowing right through the site, which could potentially cause flooding of the home site and eventually erosion at the downstream from site. Due to this recommendation the board disapprove the request.
14. **Monique Fowler** - Requesting for land in Hondah, Board approved her request.
15. **Michael Endfield** – Relinquishing land in Cradle Board back to the Tribe and requesting for land site in Dry Valley. Both requests approved by the Board.
16. **Rosita Bullock** - Requesting for a Land site in Whiteriver. Board approved the request.
17. **Robert Lupe Jr.**,-Requesting for Land site in North Fork area. Board approved.
18. **Lucinda Cohoe** – Need more information on application.
19. **Gary Thompson** – Requesting additional land to his land site. The land he is requesting for is already assigned and was once a right a way. Raymus will check into this with Realty Office.
20. **Leroy Cosay** – Requesting for land site in Canyon Day. Board Approved.
21. **Lavenia Caddo** – Requesting for land in Northside Whiteriver. Board ask McDaniel to check into this.
