

## RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

(Authorizing Alfred L. Garcia, Jr. to be buried at the Whiteriver Cemetery)

WHEREAS, the Tribal Council of the White Mountain Apache Tribe is empowered to regulate the uses and disposition of tribal property; and

WHEREAS, Alfred Garcia, Jr. passed away on March 23, 2006 and was a good friend to the Tribe; and

WHEREAS, Leandro Garcia, Sr. and family have requested that Alfred Garcia, Jr. be buried at the Whiteriver Cemetery located in Whiteriver on the Fort Apache Reservation.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes Alfred L. Garcia, Jr. to be buried at the Whiteriver Ceremony.

The foregoing resolution was on March 27, 2006, duly adopted by a vote of SIX for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (h), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe on September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
