**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

(Recommending Appointment of Lincoln Perry as Acting Police Chief)

WHEREAS, pursuant to Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe, and appoint tribal officials and employees; and

WHEREAS, pursuant to Resolution No. 05-2006-141, the Council previously appointed Frank Johnny Endfield, Jr. to the position of Chief of the White Mountain Apache Tribe Police Department ("WMAPD"), subject to a satisfactory background check and full certification by AZPOST and the BIA; and

WHEREAS, Mr. Endfield met with the Deputy Tribal Attorney and declined the position of Police Chief; and

WHEREAS, Resolution No. 05-2006-141 also re-placed Lincoln Perry to the position of Lieutenant; and


WHEREAS, the Tribal Council finds that the temporary appointment of Lincoln Perry as Acting Police Chief of the WMAPD to be in the best interests of the Tribe until such time as a replacement is found for the Police Chief position.

BE IT RESOLVED by the White Mountain Apache Tribal Council that it hereby appoints Lincoln Perry as the WMAPD Acting Police Chief until such time as a replacement is found for the Police Chief position, and all other Resolutions that are inconsistent with this Resolution are hereby rescinded.

The foregoing resolution was on May 12, 2006, duly adopted by a vote of SEVEN for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
