

RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

(Approval to grant tribal relinquishment request of Kristian Davon Aguino)

- WHEREAS, tribal member Kristian Davon Aguino, dob: 01/28/1992, daughter of David Howard Aguino, Jr. and Valerie (Way) Aguino, has requested that her tribal membership with the White Mountain Apache Tribe be relinquished so that he may become eligible for enrollment with the San Juan Pueblo; and
- WHEREAS, the necessary documents of relinquishment of head rights was signed by Valerie (Way) Aguino in the presence of a Notary Public on the 2nd day of May, 2006 and are attached hereto; and
- WHEREAS, the Tribal Enrollment Committee approved this relinquishment request at their meeting on May 9, 2006.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby grants the tribal relinquishment request of Kristian Davon Aguino, and his tribal membership with the White Mountain Apache Tribe is relinquished, along with any and all privileges accorded members of the White Mountain Apache Tribe such as, but not limited to, hunting, fishing, and recreational privileges upon the Fort Apache Indian Reservation.
- **BE IT FURTHER RESOLVED** by the Tribal Council that it hereby directs the Office of Vital Records to remove Kristian Davon Aguino from the membership rolls of the White Mountain Apache Tribe.

The foregoing resolution was on May 17, 2006, duly adopted by a vote of TEN for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section II of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
