

RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

(Approving Budgets for Fiscal Year 2006-2007)

WHEREAS, the Budget and Finance Committee did present its recommendations for Fiscal Year (FY) 2006-2007 and finds that, despite cuts in programs dependent on Rodeo-Chediski funds and two administrative, non-essential positions, the Tribe has a deficit of \$8.6 million, as attached and incorporated by this reference; and

WHEREAS, the Budget and Finance Committee recommends the following interim measures:

- 1. closure of the Homeless Program unless funded by some other source;
- 2. closure of the Cabinet Shop unless funded by other sources or revenues;
- 3. closure of all other departments funded by the Rodeo-Chediski Account;
- 4. discontinue the Business Manager position from the budget;
- 5. discontinue the Internal Auditor position from the budget; and
- **WHEREAS,** the Tribal Council has reviewed the entire proposed fiscal year 2006-2007 budget for the Central Tribe; and
- WHEREAS, the Tribal Council, at its meeting of June 13, 2006, did act on two other recommendations of the Committee, the Cost of Living Adjustment (Resolution No. 06-2006-212) and rescinding Resolution No. 04-2006-130 (Resolution No. 06-2006-211); and
- WHEREAS, the Tribal Council did not act on the Central Tribe Budget at its meeting of June 13, 2006; and
- WHEREAS, the budget continuance provided under Resolution No. 04-2006-124 was for sixty days through June 30, 2006, and is set to expire today; and
- WHEREAS, the Central Tribe Operating Budget and the Enterprise Budget with the recommended adjustments, is ready for immediate implementation; and
- WHEREAS, the Tribal Council finds that deferring merit increases, new positions and capital expenditures is an interim measures to reduce the deficit and achieve a budget which is in balance with projected revenues; and
- WHEREAS, the Tribal Council further finds that the Budget Committee routinely provides quarterly reports to the Tribal Council on the status of the Central Tribe's Operating Budget and the Enterprises' Budgets in accordance with current budget review procedures; and
- WHEREAS, the Tribal Council further finds that the Controller's Office provides the Tribal Council with monthly reports on the status of the budgets and expenditures for Central Tribe and the Enterprises; and
- WHEREAS, the Tribal Council further finds that the Tribal Controller should be delegated the authority to put a "hold" on department and/or Enterprise expenditures when accounts exceed their approved budget amounts; and

WHEREAS, the Tribal Council further finds that the Controller's Office should have the authority to request documentation and written justification of any Tribal departments or programs concerning any line item variances and adjustments from the approved budget.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that:

- 1. The FY 2006-2007 Central Tribe Operating budgets is hereby approved with a total income of \$22,230,952.35 and total expenditures of \$30,866,032.28, resulting in total net deficit of \$8,635,079.93, as attached and incorporated by this reference.
- 2. The FY 2006-2007 Enterprises Operating budget with total income of \$101,547,310 and total expense of \$89,221,951.00, resulting in a total net profit of \$12,325,359.00, as attached and incorporated by this reference.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that upon review and careful evaluation, salary increases and/or new positions, and the capital budget for Central Tribe and Enterprises are hereby deferred for six months from the date of this Resolution or mid-fiscal year.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the following interim measures recommended by the Budget and Finance Committee are hereby adopted, subject to thirty days notice thereof to those affected:

- 1. closure of the Homeless Program;
- 2. closure of the Cabinet Shop;
- 3. closure of all departments funded by the Rodeo-Chediski Account;
- 4. discontinue the Business Manager position from the budget;
- 5. discontinue the Internal Audit position from the budget.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs the Tribal Controller to put a "hold" on departments/Enterprises that exceed their approved budgets, and is further authorized to direct compliance by the Tribe's divisions, departments and programs as set forth above.

The foregoing resolution was on June 30, 2006, duly adopted by a vote of SIX for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (i), (k), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
